HB 2867

Amending the act of July 25, 1967 (P. L. 183), entitled "An act authorizing the Department of Forests and Waters to lease for industrial or economic development purposes, subject to certain conditions, certain improved lands acquired under Project 70 at Quehanna, Clearfield County; and providing for cooperation with the Department of Commerce therefor, and for disposition of rentals," further regulating leases.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Subsections (d) and (e) of section 2, act of July 25, 1967 (P. L. 183), entitled "An act authorizing the Department of Forests and Waters to lease for industrial or economic development purposes, subject to certain conditions, certain improved lands acquired under Project 70 at Quehanna, Clearfield County; and providing for cooperation with the Department of Commerce therefor, and for disposition of rentals," subsection (e) amended December 21, 1967 (P. L. 891), are amended to read:

Section 2. \* \* \*

(d) Any such lease may permit the tenant to alter or expand, at its own expense and with the approval of the department first obtained, in writing, existing buildings to meet the requirements of its particular industrial operation.

(e) Every such lease shall provide for the deposit of industrial floor space rentals and sewage and water rentals in a restricted receipts fund, from which the department may draw moneys for use in maintaining, repairing, and altering the buildings and grounds including all equipment, fixtures and facilities appurtenant thereto and including the repairing, clearing, maintaining, replacing, altering and expanding of all roads, roadways and highways now existing and hereafter constructed; developing, operating and maintaining the

[existing] water and sewage disposal facilities, and replacing machinery, equipment and fixtures appurtenant thereto, at aforesaid Quehanna. Said restricted receipts fund shall be audited two years from the effective date of this act and at two-year intervals thereafter, with any residue appearing in said fund at the end of each auditing period to be deposited in the General Fund.

Section 2. This act shall take effect immediately.

Amending the act of April 9, 1929 (P. L. 177), entitled "An act providing for and reorganizing the conduct of the executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or Teachers Colleges; abolishing, creating, reorganizing or authorizing the reorganization of certain administrative departments, boards, and commissions; defining the powers and duties of the Governor and other executive and administrative officers, and of the several administrative departments, boards, commissions, and officers; fixing the salaries of the Governor, Lieutenant Governor, and certain other executive and administrative officers; providing for the appointment of certain administrative officers, and of all deputies and other assistants and employes in certain departments, boards and commissions; and prescribing the manner in which the number and compensation of the deputies and all other assistants and employes of certain departments, boards and commissions shall be determined," authorizing leases of certain State forest lands for industrial or economic development purposes.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Clause (j.1) of section 1803, act of April 9, 1929 (P. L. 177), known as "The Administrative Code of 1929," added July 25, 1967 (P. L. 184), is amended to read:

Section 1803. Forest; Powers.—The Department of Forests and Waters shall have the power:

\* \* \*

(j.1) To lease, with the approval of the Governor, and in cooperation with the Department of Commerce, those State forest lands acquired by gift from Pennsylvania State University or by acquisition from the Curtiss-Wright Corporation which are located at Quehanna, Pennsylvania, or recovered through the termination of a lease with Curtiss-Wright Corporation relating to Quehanna, Pennsylvania, and upon which are erected certain industrial buildings
