SB 1202

Amending the act of September 18, 1961 (P.L.1389), entitled "An act establishing and taking over as State highways certain county highways, or sections thereof, tunnels, bridges, viaducts and approaches thereto, in counties, and certain streets and bridges in cities of the first class and in cities of the second class, and certain streets in cities of the second class A and third class, and certain township roads and certain streets in boroughs and incorporated towns; authorizing under certain terms and conditions their construction, maintenance, repair, reconstruction and improvement by the Commonwealth; conferring certain powers upon Department of Highways and local authorities, persons, associations and corporations for sharing the cost of the maintenance and construction of such highways; and deleting certain State highways," changing a route in the City of Philadelphia.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The following route established by section 202, act of September 18, 1961 (P.L.1389), entitled "An act establishing and taking over as State highways certain county highways, or sections thereof, tunnels, bridges, viaducts and approaches thereto, in counties, and certain streets and bridges in cities of the first class and in cities of the second class, and certain streets in cities of the second class A and third class, and certain township roads and certain streets in boroughs and incorporated towns; authorizing under certain terms and conditions their construction, maintenance, repair, reconstruction and improvement by the Commonwealth; conferring certain powers upon Department of Highways and local authorities, persons, associations and corporations for sharing the cost of the maintenance and construction of such highways; and deleting certain State highways," is amended to read:

Section 202. The city streets to be taken over in the City of Philadelphia are situate and described as follows:

* * *

Route 67288. Beginning at a point on Ridge Avenue at the intersection of Allegheny Avenue; thence easterly on Allegheny Avenue to the intersection of Allegheny Avenue, Eleventh Street and Sedgley Avenue; thence northeasterly on Sedgley Avenue to the intersection of Sedgley Avenue, Ninth Street and Allegheny Avenue; thence southeasterly and easterly on Allegheny Avenue to the intersection of Allegheny Avenue and [the Delaware Expressway, a distance of about 5.6 miles] *Delaware Avenue; thence northeasterly on Delaware Avenue to the intersection of Delaware Avenue and Castor Avenue; thence*

northwesterly and westerly on Castor Avenue to the intersection of Castor Avenue and Richmond Street, a distance of about 7.2 miles.

* * *

Section 2. This act shall take effect immediately.
