## AN ACT

HB 1840

Amending the act of September 29, 1961 (P.L.1745, No.708), entitled, as amended, "An act to define, license and regulate resident and nonresident auctioneers and apprentice auctioneers in this Commonwealth, and revising, consolidating and making the law uniform relative thereto; conferring certain powers and duties on the Board of Auctioneer Examiners, the Commissioner of Professional and Occupational Affairs, the Secretary of the Commonwealth and on certain other departments and officers of the State; providing for the keeping of records and the inspection thereof; repealing certain inconsistent laws, and providing penalties," repealing certain inconsistent acts.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 31, act of September 29, 1961 (P.L.1745, No.708), known as "The Auctioneers' License Act," is amended to read: Section 31. Specific Repeals.—The following acts and parts of acts and their amendments and supplements are repealed.

The act of May 4, 1927 (P.L.519, No.336), known as "The Borough Code," reenacted and amended July 10, 1947 (P.L.1621, No.568), in so far as it relates to the licensing and regulation of auctioneers therein.

The act of June 23, 1931 (P.L.932, No.317), known as "The Third Class City Code," reenacted and amended June 28, 1951 (P.L.662, No.164), in so far as it relates to the licensing and regulation of auctioneers therein.

The act of June 24, 1931 (P.L.1206, No.331), known as "The First Class Township Code," reenacted and amended May 27, 1949 (P.L.1955, No.569), in so far as it relates to the licensing and regulation of auctioneers therein.

The act of May 1, 1933 (P.L.103, No.69), known as "The Second Class Township Code," reenacted and amended July 10, 1947 (P.L.1481, No.567), in so far as it relates to the licensing and regulation of auctioneers therein.

The act of December 9, 1783 (2 Sm.L.86), entitled "An act to revive and continue in force the acts of Assembly regulating sales by public auction, and for other purposes therein mentioned."

The act of April 2, 1822 (P.L.218, Ch.158), entitled "An act relating to Auctions and Auctioneers."

The act of March 29, 1824 (P.L.169, Ch.100), entitled "A further supplement to the several acts of the General Assembly, respecting auctions and auctioneers."

The act of April 1, 1826 (P.L.163, Ch.56), entitled "An act relating to Auctions."

The act of April 7, 1832 (P.L.361, No.140), entitled "An act regulating auctions in the city of Lancaster, and other towns in this commonwealth."

The act of April 6, 1833 (P.L.170, No.84), entitled "A supplement to the act regulating Auctions in the city of Lancaster, and other towns of this commonwealth, passed on the seventh day of April, eighteen hundred and thirty-two."

The act of April 9, 1859 (P.L.435, No.426), entitled "An act to modify the existing Auction Laws of the Commonwealth, and to provide more effectually for the Collection of the State Tax or Duty on Auction Sales, in the city of Philadelphia and county of Allegheny."

The act of April 12, 1859 (P.L.537, No.530), entitled "An act to Restrict Sales by Auction in the counties of Northampton, Dauphin and Lehigh."

The act of April 27, 1864 (P.L.639, No.535), entitled "A supplement to an act to modify the existing auction laws of this Commonwealth, and to provide more effectually for the collection of the state tax, or duty, on auction sales, in the city of Philadelphia, and the county of Allegheny, passed the ninth day of April, eighteen hundred and fifty-nine."

The act of March 25, 1873 (P.L.405, No.425), entitled "An act relating to auctioneers in the city of Philadelphia."
