SB 1642

Providing for adoption of capital projects to be financed from current revenues of the General Fund, and making appropriations.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Itemization and Authorization of Projects.—The 1974-1975 Capital Budget projects in the category of public improvement projects, to be financed from current revenues of the General Fund, are hereby itemized together with their respective estimated costs, as follows:

Section 2. Appropriations.—The following sums of money, or as much thereof as may be necessary, are hereby specifically appropriated for completion of the above itemized capital improvement projects:

(1) The sum of sixty thousand dollars (\$60,000) to the Department of Agriculture.

(2) The sum of one million thirty-one thousand five hundred dollars (\$1,031,500) to the Department of Education.

(3) The sum of two hundred eighteen thousand dollars (\$218,000) to the Historical and Museum Commission.

(4) The sum of ninety-nine thousand dollars (\$99,000) to the Department of Military Affairs.

(5) The sum of four hundred sixty-six thousand dollars (\$466,000) to the Department of Public Welfare.

Section 3. Lapse of Funds.—Whatsoever of the amounts herein appropriated are unexpended or unencumbered as of June 30, 1976, shall lapse.

Section 4. Effective Date.—This act shall take effect July 1, 1974, or, if enacted subsequent to that date, immediately.

APPROVED—This 30th day of December, A. D., 1974, except for the following item, Section 2, subsection (2) which provides as follows: “The following sums of money, or as much thereof as may be necessary, are hereby specifically appropriated for completion of the above itemized capital improvement projects:

(2) The sum of one million thirty-one thousand five hundred dollars (\$1,031,500) to the Department of Education.” I approve this item in the amount of six hundred ninety-one thousand dollars (\$691,000). I withhold my approval from the remainder of the appropriation to the Department of Education because funds for these projects were not recommended by the Department, and there is insufficient General Fund revenues to meet the cost of two projects which were added to the bill as follows:

- (5) Completion of Interior of Stadium;
Millersville State College 165,000
- (6) Rebuilding of track and construction of tennis
courts; Millersville State College 175,000
