AN ACT

SB 1153

Amending the act of December 30, 1974 (P.L.1105, No.356), entitled "A supplement to the act of February 6, 1974 (P.L.80, No.17), entitled 'An act providing for the capital budget for the fiscal year 1973-1974,' itemizing public improvement projects to be acquired or constructed by The General State Authority together with their estimated financial cost; authorizing the incurring of debt without the approval of the electors for the purpose of financing the projects stating the estimated useful life of the projects, and making an appropriation," further defining the appropriation to a certain resource center and adding a project.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. As much as relates to Project (6) of Subdivision I (Department of Commerce), Clause B of section 1, act of December 30, 1974 (P.L.1105, No.356), entitled "A supplement to the act of February 6, 1974 (P.L.80, No.17), entitled 'An act providing for the capital budget for the fiscal year 1973-1974,' itemizing public improvement projects to be acquired or constructed by The General State Authority together with their estimated financial cost; authorizing the incurring of debt without the approval of the electors for the purpose of financing the projects stating the estimated useful life of the projects, and making an appropriation," is amended and Subdivision II (Department of Environmental Resources) is amended by adding a project to read:

Section 1. Itemization and Authorization of Projects.—Additional capital projects in the category of public improvement projects to be acquired or constructed by The General State Authority, its successors or assigns, and to be financed by the incurring of debt, are hereby itemized, together with the respective estimated financial cost and the total additional amount authorized for the public improvement projects, as follows:

**(3) Flood Control Project:**

*Little Pine Creek in the area of Saxonburg Boulevard, Shaler Township, Allegheny County. (Base Construction Authorization \$500,000 and Base Land Acquisition \$500,000).*

*This project further defines the scope of the Little Pine Creek Flood Control Project approved in the act of December 30, 1974 (P.L.1088, No.351), by reallocation of the \$1,000,000 Base Construction Authorization to \$500,000 for Construction and \$500,000 for Acquisition. The project authorizations, debt authorizations and appropriations contained in the act of December 30, 1974 (P.L.1088, No.351), or in this act are not changed by this amendment.*
