## HB 2136

Establishing certain fees to be charged by the Clerk of Quarter Sessions of Philadelphia.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1725 of Title 42 of the Pennsylvania Consolidated Statutes.

Section 24(a) of the act of July 9, 1976 (P.L.586, No.142), known as the Judiciary Act of 1976.

Section 5. This act shall take effect in 60 days.
