Making appropriations from a restricted revenue account within the General Fund and from Federal augmentation funds to the Pennsylvania Public Utility Commission.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The following sums, or as much thereof as may be necessary, are specifically appropriated from the restricted revenue account within the General Fund and from Federal augmentation funds to the Pennsylvania Public Utility Commission to provide for the operation of the commission for the fiscal year July 1, 1986, to June 30, 1987, for the purposes and in the amounts shown:

(i) The following Federal augmentation amounts, or as much thereof as may be necessary, are specifically appropriated to supplement the sum authorized to be billed to utilities for the operation of the commission:

(A) "Natural Gas Pipeline Safety" - To enforce the regulations of the Natural Gas Pipeline Safety Act.

Any Federal funds which the Pennsylvania Public Utility Commission receives pursuant to these appropriations shall not be credited to any utility nor used to lower the annual assessment of any utility.

Making an appropriation from the State Employees' Retirement Fund to provide for expenses of the State Employees' Retirement Board for the fiscal year July 1, 1986, to June 30, 1987, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1986.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$4,882,000, or as much thereof as may be necessary, is hereby appropriated from the State Employees' Retirement Fund to the State Employees' Retirement Board for the payment of all salaries, wages and other compensation and travel expenses of the employees and members of the State Employees' Retirement Board, for contractual services and other expenses necessary for the proper conduct of the duties, functions and activities of the board for the fiscal year beginning July 1, 1986, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1986.

Section 2. This act shall take effect July 1, 1986, or immediately, whichever is later.

Making an appropriation from the Public School Employees' Retirement Fund to provide for expenses of the Public School Employees' Retirement Board for the fiscal year July 1, 1986, to June 30, 1987, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1986.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$10,362,000, or as much thereof as may be necessary, is hereby appropriated from the Public School Employees' Retirement Fund to the Public School Employees' Retirement Board for the payment of all salaries, wages and other compensation and travel expenses of the employees and members of the Public School Employees' Retirement Board, for contractual services and other expenses necessary for the proper conduct of the duties, functions and activities of the board for the fiscal year beginning July 1, 1986, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1986.

Section 2. This act shall take effect July 1, 1986, or immediately, whichever is later.

HB 2554

Making appropriations from the Professional Licensure Augmentation Account and from restricted revenue accounts within the General Fund to the Department of State for use by the Bureau of Professional and Occupational Affairs in support of the professional licensure boards assigned thereto.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$8,753,000, or as much thereof as may be necessary, is hereby appropriated from the Professional Licensure Augmentation Account within the General Fund to the Department of State for the operation of the Bureau of Professional and Occupational Affairs for the fiscal year July 1, 1986, to June 30, 1987, which shall include the sum of \$105,000 to be used solely for the purpose of filling ten new staff positions. This appropriation shall not be treated as an augmentation to the Department of State, general government appropriation, or any other appropriation, but shall be treated and accounted for as a separate appropriation.

Section 2. (a) The sum of \$1,212,000, or as much thereof as may be necessary, is hereby appropriated from the restricted receipts account of the State Board of Medicine, as authorized by section 907(a) of the act of October 15, 1975 (P.L.390, No.111), known as the Health Care Services Malpractice Act, for the operation of said board for the fiscal year July 1, 1986, to June 30, 1987.

(b) The sum of \$238,000, or as much thereof as may be necessary, is hereby appropriated from the restricted receipts account of the State Board of Osteopathic Medicine, as authorized by section 907(b) of the Health Care Services Malpractice Act, for the operation of said board for the fiscal year July 1, 1986, to June 30, 1987.

(c) The sum of \$107,000, or as much thereof as may be necessary, is hereby appropriated from the restricted receipts account of the State Board of Podiatry, as authorized by section 907(c) of the Health Care Services Malpractice Act, for the operation of said board for the fiscal year July 1, 1986, to June 30, 1987.

(d) Each appropriation listed in subsections (a), (b) and (c) shall not be treated as an augmentation to the Department of State, general government appropriation, or any other appropriation, but shall be treated and accounted for as separate appropriations respectively.

SB 1447

Itemizing appropriations required from the Motor License Fund for the fiscal year July 1, 1986, to June 30, 1987, for the proper operation of the several departments of the Commonwealth authorized to spend Motor License Fund moneys.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. This act shall be known and may be cited as the Motor License Fund Appropriation Act of 1986.

Section 2. The following sums, or as much thereof as may be necessary, are hereby appropriated from the Motor License Fund to the hereinafter named agencies of the Commonwealth for the payment of salaries, wages and other compensation and travel expenses of the duly elected or appointed officers and employees of the Commonwealth, for contractual services and other expenses necessary for the proper conduct of the duties, functions and activities for the purposes hereinafter set forth for the fiscal year beginning July 1, 1986, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1986:

To the Department of Transportation

For the salaries, wages and all necessary expenses for the proper administration of the Department of Transportation, including the Transportation Commission and Advisory Committee and the Statewide coordination of municipal services.....	\$20,901,000

To the Department of Transportation

For payment for aviation operations, including the operation and maintenance of State-owned aircraft, payment of general expenses, supplies, printing and equipment; for the development and maintenance of State airports and the maintenance and repair of landing fields, intermediate landing fields, landing field equipment, beacon sites and other navigation facilities; and for the encouragement and development of civil aeronautics..... \$5,320,000

SB 1451

Making appropriations from the Workmen's Compensation Administration Fund to the Department of Labor and Industry to provide for the expenses of administering The Pennsylvania Workmen's Compensation Act and The Pennsylvania Occupational Disease Act for the fiscal year July 1, 1986, to June 30, 1987, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1986.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$11,755,000, or as much thereof as may be necessary, is hereby appropriated from the Workmen's Compensation Administration Fund to the Department of Labor and Industry for the payment of all salaries, wages and other compensation and travel expenses, for contractual services and other expenses necessary for the administration of the act of June 2, 1915 (P.L.736, No.338), known as The Pennsylvania Workmen's Compensation Act, and the act of June 21, 1939 (P.L.566, No.284), known as The Pennsylvania Occupational Disease Act, for the fiscal year beginning July 1, 1986, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1986.

Section 2. The sum of \$485,000, or as much thereof as may be necessary, is hereby appropriated from the Workmen's Compensation Administration Fund to the Department of Labor and Industry for the payment of salaries, wages and other compensation necessary for increasing the filled complement level of workmen's compensation referees to 55 and for the payment of salaries, wages and other compensation necessary to provide two clerical support personnel for each referee in Workmen's Compensation field offices.

Section 3. This act shall take effect July 1, 1986, or immediately, whichever is later.

A SUPPLEMENT

HB 2510

To the act of July 28, 1966 (3rd Sp.Sess., P.L.87, No.3), entitled "An act providing for the establishment and operation of the University of Pittsburgh as an instrumentality of the Commonwealth to serve as a State-related university in the higher education system of the Commonwealth; providing for change of name; providing for the composition of the board of trustees; terms of trustees, and the power and duties of such trustees; authorizing appropriations in amounts to be fixed annually by the General Assembly; providing for the auditing of accounts of expenditures from said appropriations; providing for public support and capital improvements; authorizing the issuance of bonds exempt from taxation within the Commonwealth; requiring the chancellor to make an annual report of the operations of the University of Pittsburgh," making appropriations for carrying the same into effect; providing for a basis for payments of such appropriations; and providing a method of accounting for the funds appropriated.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The following sums, or as much thereof as may be necessary, are hereby appropriated to the Trustees of the University of Pittsburgh for the fiscal year July 1, 1986, to June 30, 1987, for the purpose and in the amounts as shown:

(1) For educational and general expenses and for participation by a representative of the institution, appointed by the chief executive officer thereof, as a member of the Pennsylvania Academic Commission on Technological Development, a commission for interinstitutional communication regarding technological innovation and development and for dissemination of information on such matters to the Pennsylvania business community and others who may use such information for new business and job development in Pennsylvania, such commission to be composed of representatives of every State-owned or State-related educational or scientific institution receiving General Fund assistance from the Commonwealth.....	\$93,176,000
(2) For instruction - Doctor of Medicine only.....	5,332,000
(3) For operation of dental clinics in the school of dentistry.....	900,000
(4) For operations of the Titusville Campus.....	716,000
(5) To enhance the recruitment and retention of disadvantaged students.....	200,000

Section 2. Payments to the University of Pittsburgh on account of the appropriations for all items as provided in section 1 shall be made on the basis of costs during the fiscal year.

Section 3. If necessary, the University of Pittsburgh may transfer funds between the appropriations listed in section 1(1) and (2): Provided, That the aggregate amount transferred into or out of each appropriation during the fiscal year shall not exceed 5% of the amount specifically appropriated for that purpose.

Section 4. (a) Payments to the University of Pittsburgh of the appropriations provided in section 1 shall be made monthly during the fiscal year.

(b) Such monthly payments shall be made in accordance with the provisions of section 2 on the basis of estimated costs. The estimate of costs shall be submitted by the University of Pittsburgh to the Secretary of Education, the General Assembly and the State Treasurer not later than 30 days prior to the date on which such payment is to be made.

Section 5. (a) The University of Pittsburgh shall apply the moneys appropriated by this act only for such purposes as are permitted in this act and shall at all times maintain proper records showing the application of such moneys. Not later than 120 days after the close of the fiscal year to which this act relates, the University of Pittsburgh shall file, with the Secretary of Education, the General Assembly, the Auditor General of the Commonwealth and the chief administrator of each branch campus, a statement setting forth the amounts and purposes of all expenditures made from moneys appropriated by this act and other university accounts during said fiscal year, as provided in section 2, used as a basis for receipt of any appropriation during said fiscal year.

(b) Such statement of expenditures and costs shall be reviewed by the Auditor General of the Commonwealth, and he shall have the right, in respect to the moneys appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered and paid by the University of Pittsburgh to the State Treasurer. In respect to expenditures made by the university from moneys other than those appropriated by this act, the Auditor General shall have the right to review only, and he shall file annually with the General Assembly such information concerning such expenditures as the General Assembly or any of its committees may require.

Section 6. A report shall be submitted to the Governor and the Appropriations and Education Committees of the Senate and House of Representatives and shall include data for all programs, except for the Doctor of Medicine program. The report, to be submitted prior to September 1, 1987, shall cover the 12-month period beginning with the summer term 1986 and shall include:

(1) The following counts and distributions for each term during the period:

(i) The definitions and numbers of faculty members employed full time, of faculty members employed part time, of full-time students enrolled in graduate courses, of full-time students enrolled in undergraduate courses, of part-time students enrolled in graduate courses and of part-time students enrolled in undergraduate courses.

(ii) The total numbers of undergraduate student credit hours, divided into lower division and upper division course levels, and of graduate student credit hours divided into three course levels—master's, first professional and doctoral.

(iii) The number of different courses scheduled by level of instruction and the number of sections of individual instruction scheduled by level of instruction, each further subdivided by two-digit Classification of Instructional Program (CIP) categories of instructional programs of higher education as defined by the National Center for Education Statistics, United States Department of Education.

(iv) The number of terms scheduled and the dates thereof.

(2) For the summer term and the following academic year in total and for each two-digit CIP program category, a classification of faculty members or other professional employees by title, including: professor, associate professor, assistant professor, instructor, lecturer, research associate, librarian and academic administrator; faculty members or other professional employees under each title to be subdivided by type of assignment: teaching and non-teaching, and each such set of faculty members or other professional employees to be further subdivided by type of employment: full-time or part-time and the following aggregates for each such subdivided classification:

(i) The number of faculty and other professional employees and their full-time equivalence in instructional and noninstructional functions.

(ii) The sum of credits assigned to undergraduate classroom courses and the sum of credits assigned to graduate classroom courses taught, divided into lower division, upper division, master's, first professional and doctoral course levels.

(iii) The sum of credits assigned to undergraduate individual instruction courses and the sum of credits assigned to graduate individual instruction courses taught, divided into lower division, upper division, master's, first professional and doctoral course levels.

(iv) The sum of undergraduate classroom student credit hours and the sum of graduate classroom student credit hours generated, divided into lower division, upper division, master's, first professional and doctoral course levels.

(v) The sum of undergraduate individual instruction student credit hours and the sum of graduate individual instruction student credit hours generated, divided into lower division, upper division, master's, first professional and doctoral course levels.

(vi) The total salary paid for instructional functions and for noninstructional functions and the amount of this salary paid for each of these functions from university funds, Federal funds and other funds.

(3) For each term of the period covered for each faculty member employed full time identified by two-digit CIP program category and title, the report shall contain an analysis of the average hours per week spent in university-related activities, stating specifically hours spent in undergraduate classroom contact and graduate classroom contact, hours spent in preparation, hours spent in research and hours spent in public service.

Section 7. In addition to the requirements in section 6 relative to this appropriation, the report covering the 12-month period beginning with the summer term 1986 shall include for all programs of the university:

(1) Minimum number of credits required for a baccalaureate degree and for a master's degree.

(2) Number of bachelor's degrees, master's degrees, first professional degrees and doctoral degrees awarded in 1984, 1985, 1986 and estimated 1987.

Section 8. The University of Pittsburgh shall provide such information as may be necessary to carry out the provisions of this act and in such form and manner as the Department of Education shall prescribe.

Section 9. The University of Pittsburgh shall report its revenues and expenditures and present its financial statements required under the provisions of this act in accordance with generally accepted accounting principles and procedures for educational institutions as set forth in the "Higher Education Finance Manual of 1975," United States Department of Health, Education and Welfare (1975), with the exceptions set forth in the "Commonwealth of Pennsylvania Budget Instructions for State-Related Universities, Phase I, Fiscal Year 1986-1987." Credits granted for nontraditional programs such as CLEP, lifelong learning, etc., including all related costs and revenues thereof, shall be excluded from the function of "Instruction" and included under "Public Service."

Section 10. This act shall take effect July 1, 1986, or immediately, whichever is later.

To the act of November 30, 1965 (P.L.843, No.355), entitled "An act providing for the establishment and operation of Temple University as an instrumentality of the Commonwealth to serve as a State-related university in the higher education system of the Commonwealth; providing for change of name; providing for the composition of the board of trustees; terms of trustees, and the power and duties of such trustees; providing for preference to Pennsylvania residents in tuition; providing for public support and capital improvements; authorizing appropriations in amounts to be fixed annually by the General Assembly; providing for the auditing of accounts of expenditures from said appropriations; authorizing the issuance of bonds exempt from taxation within the Commonwealth; requiring the President to make an annual report of the operations of Temple University," making appropriations for carrying the same into effect; providing for a basis for payments of such appropriations; and providing a method of accounting for the funds appropriated.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The following sums, or as much thereof as may be necessary, are hereby appropriated to the Trustees of Temple University for the fiscal year July 1, 1986, to June 30, 1987, for the purposes and in the amounts as shown:

(1) For educational and general expenses and for participation by a representative of the institution, appointed by the chief executive officer thereof, as a member of the Pennsylvania Academic Commission on Technological Development, a commission for interinstitutional communication regarding technological innovation and development and for dissemination of information on such matters to the Pennsylvania business community and others who may use such information for new business and job development in Pennsylvania, such commission to be composed of representatives of every State-owned or State-related educational or scientific institution receiving General Fund assistance from the Commonwealth.....	\$102,085,000
(2) For instruction - Doctor of Medicine only.....	7,098,000
(3) For operation of dental clinics in the school of dentistry.....	900,000
(4) To enhance the recruitment and retention of disadvantaged students.....	200,000

Section 2. Payments to Temple University on account of the appropriations for all items as provided in section 1 shall be made on the basis of costs during the fiscal year.

Section 3. If necessary, Temple University may transfer funds among the appropriations listed in section 1(1) and (2): Provided, That the aggregate amount transferred into or out of each appropriation during the fiscal year shall not exceed 5% of the amount specifically appropriated for that purpose.

Section 4. (a) Payment to Temple University of the appropriations provided in section 1 shall be made monthly during the fiscal year.

(b) Such monthly payments shall be made in accordance with the provisions of section 2 on the basis of estimated costs. The estimate of costs shall be submitted by Temple University to the Secretary of Education, the General Assembly and the State Treasurer not later than 30 days prior to the date on which such payment is to be made.

Section 5. (a) Temple University shall apply the moneys appropriated by this act only for such purposes as are permitted in this act and shall at all times maintain proper records showing the application of such moneys. Not later than 120 days after the close of the fiscal year to which this act relates, Temple University shall file, with the Secretary of Education, the General Assembly and the Auditor General of the Commonwealth, a statement setting forth the amounts and purposes of all expenditures made from moneys appropriated by this act and other university accounts during said fiscal year, as provided in section 2, used as a basis for receipt of any appropriation during said fiscal year.

(b) Such statement of expenditures and costs shall be reviewed by the Auditor General of the Commonwealth, and he shall have the right, in respect to the moneys appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered and paid by Temple University to the State Treasurer. In respect to expenditures made by the university from moneys other than those appropriated by this act, the Auditor General shall have the right to review only, and he shall file annually with the General Assembly such information concerning said expenditures as the General Assembly or any of its committees may require.

Section 6. A report shall be submitted to the Governor and the Appropriations and Education Committees of the Senate and House of Representatives and shall include data for all programs except the Doctor of Medicine program. The report, to be submitted prior to September 1, 1987, shall cover the 12-month period beginning with the summer term 1986 and shall include:

(1) The following counts and distributions for each term during the period:

(i) The definitions and numbers of faculty members employed full time, of faculty members employed part time, of full-time students enrolled in graduate courses, of full-time students enrolled in undergraduate courses, of part-time students enrolled in graduate courses and of part-time students enrolled in undergraduate courses.

(ii) The total numbers of undergraduate student credit hours, divided into lower division and upper division course levels, and of graduate student credit hours divided into three course levels—master's, first professional and doctoral.

(iii) The number of different courses scheduled by level of instruction and the number of sections of individual instruction scheduled by level of instruction, each further subdivided by two-digit Classification of Instructional Program (CIP) categories of instructional programs of higher education as defined by the National Center for Education Statistics, United States Department of Education.

(iv) The number of terms scheduled and the dates thereof.

(2) For the summer term and the following academic year in total and for each two-digit CIP program category, a classification of faculty members or other professional employees by title, including: professor, associate professor, assistant professor, instructor, lecturer, research associate, librarian and academic administrator; faculty members or other professional employees under each title to be subdivided by type of assignment: teaching and non-teaching, and each such set of faculty members or other professional employees to be further subdivided by type of employment: full-time or part-time and the following aggregates for each such subdivided classification:

(i) The number of faculty and other professional employees and their full-time equivalence in instructional and noninstructional functions.

(ii) The sum of credits assigned to undergraduate classroom courses and the sum of credits assigned to graduate classroom courses taught, divided into lower division, upper division, master's, first professional and doctoral course levels.

(iii) The sum of credits assigned to undergraduate individual instruction courses and the sum of credits assigned to graduate individual instruction courses taught, divided into lower division, upper division, master's, first professional and doctoral course levels.

(iv) The sum of undergraduate classroom student credit hours and the sum of graduate classroom student credit hours generated, divided into lower division, upper division, master's, first professional and doctoral course levels.

(v) The sum of undergraduate individual instruction student credit hours and the sum of graduate individual instruction student credit hours generated, divided into lower division, upper division, master's, first professional and doctoral course levels.

(vi) The total salary paid for instructional functions and for noninstructional functions and the amount of this salary paid for each of these functions from university funds, Federal funds and other funds.

(3) For each term of the period covered for each faculty member employed full time identified by two-digit CIP program category and title, the report shall contain an analysis of the average hours per week spent in university-related activities, stating specifically hours spent in undergraduate classroom contact and graduate classroom contact, hours spent in preparation, hours spent in research and hours spent in public service.

Section 7. In addition to the requirements in section 6 relative to this appropriation, each report covering the 12-month period beginning with the summer term 1986 shall include for all programs of the university:

(1) Minimum number of credits required for a baccalaureate degree and for a master's degree.

(2) Number of bachelor's degrees, master's degrees, first professional degrees and doctoral degrees awarded in 1984, 1985, 1986 and estimated 1987.

Section 8. Temple University shall provide such information as may be necessary to carry out this act and in such form and manner as the Department of Education shall prescribe.

Section 9. Temple University shall report its revenues and expenditures and present its financial statements required under the provisions of this act in accordance with generally accepted accounting principles and procedures for educational institutions as set forth in the "Higher Education Finance Manual of 1975," United States Department of Health, Education and Welfare (1975), with the exceptions set forth in the "Commonwealth of Pennsylvania Budget Instructions for State-Related Universities, Phase I, Fiscal Year 1986-1987." Credits granted for nontraditional programs such as CLEP, lifelong learning, etc., including all related costs and revenues thereof, shall be excluded from the function of "Instruction" and included under "Public Service."

Section 10. This act shall take effect July 1, 1986, or immediately, whichever is later.

To the act of July 7, 1972 (P.L.743, No.176), entitled "An act providing for the establishment and operation of Lincoln University as an instrumentality of the Commonwealth to serve as a State-related institution in the higher education system of the Commonwealth; providing for change of name; providing for the composition of the board of trustees; terms of trustees, and the power and duties of such trustees; providing for preference to Pennsylvania residents in tuition; authorizing appropriations in amounts to be fixed annually by the General Assembly; providing for the auditing of accounts of expenditures from said appropriations; providing for public support and capital improvements; authorizing the issuance of bonds exempt from taxation within the Commonwealth; requiring the President to make an annual report of the operations of Lincoln University," making appropriations for carrying the same into effect; providing for a basis for payments of such appropriations; and providing a method of accounting for the funds appropriated.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The following sums, or as much thereof as may be necessary, are hereby appropriated to the Trustees of Lincoln University, Chester County, for the fiscal year July 1, 1986, to June 30, 1987, for the purposes and in the amounts as shown:

- (1) For educational and general expenses and for participation by a representative of the institution, appointed by the chief executive officer thereof, as a member of the Pennsylvania Academic Commission on Technological Development, a commission for interinstitutional communication regarding technological innovation and development and for dissemination of information on such matters to the Pennsylvania business community and others who may use such information for new business and job development in Pennsylvania, such commission to be composed of representatives of every State-owned or State-related educational or scientific institution receiving General Fund assistance from the Commonwealth..... \$6,363,000
- (2) To enhance the recruitment and retention of disadvantaged students..... 200,000
- (3) To enhance the opportunity for equal education at Lincoln University in accordance with the plan submitted by the Department of Education and approved by the United States Office of Civil Rights and the appropriation to be managed and supervised by the Department of Education..... 1,000,000

Section 2. Payments to Lincoln University on account of the appropriations for the items provided in section 1 shall be made on the basis of costs during the fiscal year.

Section 3. (a) Payments to Lincoln University of the appropriations provided in section 1 shall be made monthly during the fiscal year.

(b) Such monthly payments shall be made in accordance with the provisions of section 2 on the basis of estimated costs. The estimate of costs shall be submitted by Lincoln University to the Secretary of Education, the General Assembly and the State Treasurer not later than 30 days prior to the date on which such payment is to be made.

Section 4. (a) Lincoln University shall apply the moneys appropriated by this act only for such purposes as are permitted in this act and shall at all times maintain proper records showing the application of such moneys. Not later than 120 days after the close of the fiscal year to which this act relates, Lincoln University shall file, with the Secretary of Education, the General Assembly and the Auditor General of the Commonwealth, a statement setting forth the amounts and purposes of all expenditures made from moneys appropriated by this act and costs, as provided in section 2, used as a basis for receipt of any appropriation during said fiscal year.

(b) Such statement of expenditures and costs shall be reviewed by the Auditor General of the Commonwealth, and he shall have the right, in respect to the moneys appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered and paid by Lincoln University to the State Treasurer. In respect to expenditures made by the university from moneys other than those appropriated by this act, the Auditor General shall have the right to review only, and he shall file annually with the General Assembly such information concerning said expenditures as the General Assembly or any of its committees may require.

Section 5. A report shall be submitted to the Governor and the Appropriations and Education Committees of the Senate and House of Representatives and shall include data for all programs. The report, to be submitted prior to September 1, 1987, shall cover the 12-month period beginning with the summer term 1986 and shall include:

(1) The following counts and distributions for each term during the period:

(i) The definitions and numbers of faculty members employed full time, of faculty members employed part time, of full-time students enrolled in graduate courses, of full-time students enrolled in undergraduate courses, of part-time students enrolled in graduate courses and of part-time students enrolled in undergraduate courses.

Section 6. In addition to the requirements in section 5 relative to this appropriation, the report covering the 12-month period beginning with the summer term 1986 shall include for all programs of the university:

(1) Minimum number of credits required for a baccalaureate degree and for a master's degree.

(2) Number of bachelor's degrees, master's degrees, first professional degrees and doctoral degrees awarded in 1984, 1985, 1986 and estimated 1987.

Section 7. Lincoln University shall provide such information as may be necessary to carry out the provisions of this act and in such form and manner as the Department of Education shall prescribe.

Section 8. Lincoln University shall report its revenues and expenditures and present its financial statements required under the provisions of this act in accordance with generally accepted accounting principles and procedures for educational institutions as set forth in the "Higher Education Finance Manual of 1975," United States Department of Health, Education and Welfare (1975), with the exceptions set forth in the "Commonwealth of Pennsylvania Budget Instructions for State-Related Universities, Phase I, Fiscal Year 1986-1987." Credits granted for nontraditional programs such as CLEP, lifelong learning, etc., including all related costs and revenues thereof, shall be excluded from the function of "Instruction" and included under "Public Service."

Section 9. This act shall take effect July 1, 1986, or immediately, whichever is later.

A SUPPLEMENT

HB 2509

To the act of April 1, 1863 (P.L.213, No.227), entitled "An act to accept the grant of Public Lands, by the United States, to the several states, for the endowment of Agricultural Colleges," making appropriations for carrying the same into effect; providing for a basis for payments of such appropriations; and providing a method of accounting for the funds appropriated.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. In order to carry into effect the act of Congress, approved July 2, 1862, granting public land to the several states for educational purposes, and subsequent acts of Congress related thereto, and the act of the General Assembly of Pennsylvania accepting the provisions and conditions of said acts of Congress and pledging the faith of the State to carry the same into effect, the following sums, or as much thereof as may be necessary, are hereby appropriated to the Trustees of The Pennsylvania State University for the fiscal year July 1, 1986, to June 30, 1987, for the purposes and in the amounts as shown:

- (1) For educational and general expenses and for participation by a representative of the institution, appointed by the chief executive officer thereof, as a member of the Pennsylvania Academic Commission on Technological Development, a commission for interinstitutional communication regarding technological innovation and development and for dissemination of information on such matters to the Pennsylvania business community and others who may use such information for new business and job development in Pennsylvania, such commission to be composed of representatives of every State-owned or State-related educational or scientific institution receiving General Fund assistance from the Commonwealth..... \$135,965,000
- (2) For cost of research..... 11,884,000
- (3) For instruction - Doctor of Medicine only..... 3,781,000
- (4) For cost of agricultural research..... 14,144,000
- (5) For cost of agricultural extension services..... 11,968,000
- (6) For the cost of operating Elizabethtown Hospital... 3,982,000
- (7) To enhance the recruitment and retention of disadvantaged students..... 200,000

Section 2. Payments to The Pennsylvania State University on account of the appropriations for all items as provided in section 1 shall be made on the basis of costs during the fiscal year.

Section 3. If necessary, The Pennsylvania State University may transfer funds among the appropriations listed in section 1(1), (2), (4) and (5): Pro-

vided, That the aggregate amount transferred into or out of each appropriation during the fiscal year shall not exceed 5% of the amount specifically appropriated for that purpose.

Section 4. (a) Payments to The Pennsylvania State University of the appropriations provided in section 1 shall be made monthly during the fiscal year.

(b) Such monthly payments shall be made in accordance with the provisions of section 2 on the basis of estimated costs. The estimate of costs shall be submitted by The Pennsylvania State University to the Secretary of Education, the General Assembly and the State Treasurer not later than 30 days prior to the date on which such payment is to be made.

Section 5. Notwithstanding any provision of the General Appropriation Act of 1986 relating to the payment of retirement expenses, the Trustees of The Pennsylvania State University shall make all required payments to the State Employees' Retirement Fund from the funds appropriated pursuant to this act.

Section 6. (a) The Pennsylvania State University shall apply the moneys appropriated by this act only for such purposes as are permitted in this act and shall at all times maintain proper records showing the application of such moneys. Not later than 120 days after the close of the fiscal year to which this act relates, The Pennsylvania State University shall file, with the Secretary of Education, the General Assembly and the Auditor General of the Commonwealth, a statement setting forth the amounts and purposes of all expenditures made from moneys appropriated by this act and other university accounts during said fiscal year, as provided in section 2, used as a basis for receipt of any appropriation during said fiscal year.

(b) Such statement of expenditures and costs shall be reviewed by the Auditor General of the Commonwealth, and he shall have the right, in respect to the moneys appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered and paid by The Pennsylvania State University to the State Treasurer. In respect to expenditures made by the university from moneys other than those appropriated by this act, the Auditor General shall have the right to review only, and he shall file annually with the General Assembly such information concerning such expenditures as the General Assembly or any of its committees may require.

Section 7. A report shall be submitted to the Governor and the Appropriations and Education Committees of the Senate and House of Representatives and shall include data for all programs except the Doctor of Medicine program. The report, to be submitted prior to September 1, 1987, shall cover the 12-month period beginning with the summer term 1986 and shall include:

(1) The following counts and distributions for each term during the period:

(i) The definitions and numbers of faculty members employed full time, of faculty members employed part time, of full-time students enrolled in graduate courses, of full-time students enrolled in undergraduate courses, of part-time students enrolled in graduate courses and of part-time students enrolled in undergraduate courses.

(ii) The total numbers of undergraduate student credit hours, divided into lower division and upper division course levels, and of graduate student credit hours, divided into three course levels—master's, first professional and doctoral.

(iii) The number of different courses scheduled by level of instruction and the number of sections of individual instruction scheduled by level of instruction, each further subdivided by two-digit Classification of Instructional Program (CIP) categories of instructional programs of higher education as defined by the National Center for Education Statistics, United States Department of Education.

(iv) The number of terms scheduled and the dates thereof.

(2) For the summer term and the following academic year in total and for each two-digit CIP program category, a classification of faculty members or other professional employees by title, including: professor, associate professor, assistant professor, instructor, lecturer, research associate, librarian and academic administrator; faculty members or other professional employees under each title to be subdivided by type of assignment: teaching and non-teaching, and each such set of faculty members or other professional employees to be further subdivided by type of employment: full-time or part-time and the following aggregates for each such subdivided classification:

(i) The number of faculty and other professional employees and their full-time equivalence in instructional and noninstructional functions.

(ii) The sum of credits assigned to undergraduate classroom courses and the sum of credits assigned to graduate classroom courses taught, divided into lower division, upper division, master's, first professional and doctoral course levels.

(iii) The sum of credits assigned to undergraduate individual instruction courses and the sum of credits assigned to graduate individual instruction courses taught, divided into lower division, upper division, master's, first professional and doctoral course levels.

(iv) The sum of undergraduate classroom student credit hours and the sum of graduate classroom student credit hours generated, divided into lower division, upper division, master's, first professional and doctoral course levels.

(v) The sum of undergraduate individual instruction student credit hours and the sum of graduate individual instruction student credit hours generated, divided into lower division, upper division, master's, first professional and doctoral course levels.

(vi) The total salary paid for instructional functions and for noninstructional functions and the amount of this salary paid for each of these functions from university funds, Federal funds and other funds.

(3) For each term of the period covered for each faculty member employed full time identified by two-digit CIP program category and title, the report shall contain an analysis of the average hours per week spent in university-related activities, stating specifically hours spent in undergraduate classroom contact and graduate classroom contact, hours spent in preparation, hours spent in research and hours spent in public service.

Section 8. In addition to the requirements in section 7 relative to this appropriation, the report covering the 12-month period beginning with the summer term 1986 shall include for all programs of the university:

(1) Minimum number of credits required for a baccalaureate degree and for a master's degree.

(2) Number of bachelor's degrees, master's degrees, first professional degrees and doctoral degrees awarded in 1984, 1985, 1986 and estimated 1987.

Section 9. The Pennsylvania State University shall provide such information as may be necessary to carry out the provisions of this act and in such form and manner as the Department of Education shall prescribe.

Section 10. The Pennsylvania State University shall report its revenues and expenditures and present its financial statements required under the provisions of this act in accordance with generally accepted accounting principles and procedures for educational institutions as set forth in the "Higher Education Finance Manual of 1975," United States Department of Health, Education and Welfare (1975), with the exceptions set forth in the "Commonwealth of Pennsylvania Budget Instructions for State-Related Universities, Phase I, Fiscal Year 1986-1987." Credits granted for nontraditional programs such as CLEP, lifelong learning, etc., including all related costs and revenues thereof, shall be excluded from the function of "Instruction" and included under "Public Service."

Section 11. This act shall take effect July 1, 1986, or immediately, whichever is later.

For alcohol and chemical abuse instruction to be provided to all public and nonpublic school students as part of the health course of study required in accordance with State Board of Education regulations.

State appropriation..... \$1,000,000

Section 2. The following State General Fund amount is hereby appropriated to the Department of Health for the fiscal year July 1, 1986, to June 30, 1987, for drug and alcohol treatment programs for women with children:

For drug and alcohol treatment programs for women with children. To insure the most expeditious use of these funds, it is the intent of the General Assembly that the department allocate this appropriation to organizations providing drug and alcohol treatment to women with children as of July 1, 1986.

State appropriation..... 500,000

Section 3. The following State General Fund and Federal Block Grant Fund amounts are hereby appropriated to the Department of Public Welfare for the fiscal year July 1, 1986, to June 30, 1987:

I withhold my approval of these appropriations.

This legislation is necessary for one reason only; the need to remove extraordinary language which had threatened State and Federal funding to the counties for their vital human services programs. I welcome the opportunity to approve a bill which strikes out this language and removes the uncertainty surrounding human services funding. I approve the small additional appropriation which assures at least a 3.5 % funding increase for all counties. I am deleting the additional amounts because they were added in the haste of passing the needed legislation without sufficient discussion and demonstration of their necessity, and because they go beyond the unappropriated surplus now available.

It is the intent of the General Assembly that the appropriation in section 2 will be loaned to Genesis Packaging Systems, Inc., at an annual interest rate of 3% for a term not to exceed 15 years. Section 2. Payments to the Thomas Jefferson University on account of the appropriations provided in section 1 shall be made quarterly by the Secretary of Education on the basis of costs during the fiscal year.

Section 3. The Thomas Jefferson University shall provide such information as may be necessary to carry out the provisions of this act and in such form and manner as the Department of Education shall prescribe.

Section 4. The Thomas Jefferson University shall report its revenues and expenditures and present its financial statements in accordance with generally accepted accounting principles and procedures for educational institutions as set forth in the "Higher Education Finance Manual of 1975," without exception.

The sum set forth in this act, or as much thereof as may be necessary, is hereby specifically appropriated from the Sunny Day Fund to the Department of Commerce for the fiscal year July 1, 1986, to June 30, 1987, for the project listed to enhance economic development and the creation of jobs in this Commonwealth in accordance with the provisions of Chapter 1 of the act of July 1, 1985 (P.L.120, No.32), known as the Sunny Day Fund Act.

Section 2. The following amount is appropriated to the Department of Commerce to induce Eastman Kodak Company (Kodak) to locate a research and development facility in Chester County:

State appropriation.....\$14,710,000

Section 3. It is the intent of the General Assembly that the appropriation in section 2 will be used to fund the cost of special tenant improvements to an interim research and development pharmaceutical facility leased to Kodak by the Department of Commerce as provided in the memorandum of intent between the Governor's Office of the Commonwealth, Kodak and Rouse Associates, dated November 14, 1986. The Department of Commerce will also lease the basic facility and sublease it to Kodak. The initial term of the lease will be for five years, during which time Kodak is expected to construct a permanent facility in Pennsylvania to conduct research and development activities in connection with its pharmaceutical business. All or a portion of the department's funding of the special tenant improvements will be recovered (i) to the extent the annual rental on the department's lease to Kodak, or its successor, exceeds the department's rent obligation for the interim facility, and (ii) upon the sale or other disposition of the leased facility, through the department's receipt of net proceeds allocable to the appraised value of the special tenant improvements. It is expected that this project will create at least 300 new full-time jobs during the first three years at the interim facility and several thousand jobs when the permanent facility is constructed in the greater Philadelphia area.

Section 4. The Department of Commerce is authorized to execute and deliver the lease and sublease referred to in section 3 and all other documents necessary to consummate the transactions relating to the project.
