SB 791

Making an appropriation from the State Employees' Retirement Fund to provide for expenses of the State Employees' Retirement Board for the fiscal year July 1, 2007, to June 30, 2008, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2007.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$26,568,000, or as much thereof as may be necessary, is hereby appropriated from the State Employees' Retirement Fund to the State Employees' Retirement Board for the payment of all salaries, wages and other compensation and travel expenses of the employees and members of the State Employees' Retirement Board, for contractual services and other expenses necessary for the proper conduct of the duties, functions and activities of the board for the fiscal year beginning July 1, 2007, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2007.

Section 2. This act shall take effect July 1, 2007, or immediately, whichever is later.

AN ACT

SB 792

Making an appropriation from the Public School Employees' Retirement Fund to provide for expenses of the Public School Employees' Retirement Board for the fiscal year July 1, 2007, to June 30, 2008, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2007.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$40,811,000, or as much thereof as may be necessary, is hereby appropriated from the Public School Employees' Retirement Fund to the Public School Employees' Retirement Board for the payment of all salaries, wages and other compensation and travel expenses of the employees and members of the Public School Employees' Retirement Board, for contractual services and other expenses necessary for the proper conduct of the duties, functions and activities of the board for the fiscal year beginning July 1, 2007, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2007.

Section 2. This act shall take effect July 1, 2007, or immediately, whichever is later.

AN ACT

SB 793

Making appropriations from the Professional Licensure Augmentation Account and from restricted revenue accounts within the General Fund to the Department of State for use by the Bureau of Professional and Occupational Affairs in support of the professional licensure boards assigned thereto.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

- Section 1. The sum of \$31,523,000, or as much thereof as may be necessary, is hereby appropriated from the Professional Licensure Augmentation Account within the General Fund to the Department of State for the operation of the Bureau of Professional and Occupational Affairs, including the State Board of Auctioneer Examiners, for the fiscal year July 1, 2007, to June 30, 2008.
- Section 2. (a) The sum of \$8,165,000, or as much thereof as may be necessary, is hereby appropriated from the restricted receipts account of the State Board of Medicine for the operation of the board for the fiscal year July 1, 2007, to June 30, 2008.
- (b) The sum of \$1,223,000, or as much thereof as may be necessary, is hereby appropriated from the restricted receipts account of the State Board of Osteopathic Medicine for the operation of the board for the fiscal year July 1, 2007, to June 30, 2008.
- (c) The sum of \$252,000, or as much thereof as may be necessary, is hereby appropriated from the restricted receipts account of the State Board of Podiatry for the operation of said board for the fiscal year July 1, 2007, to June 30, 2008.
- (d) The sum of \$446,000, or as much thereof as may be necessary, is hereby appropriated from the Athletic Commission Augmentation Account for the State Athletic Commission, as authorized by 5 Pa.C.S. § 1512 (relating to Athletic Commission Augmentation Account), for the support and operation of the commission for the fiscal year July 1, 2007, to June 30, 2008.
- (e) Each appropriation listed in subsections (a), (b), (c) and (d) shall not be treated as an augmentation to the Department of State, general government appropriation or any other appropriation, but shall be treated and accounted for as separate appropriations respectively.
- Section 3. This act shall take effect July 1, 2007, or immediately, whichever is later.

AN ACT

SB 794

Making appropriations from the Workmen's Compensation Administration Fund to the Department of Labor and Industry and the Department of Community and Economic Development to provide for the expenses of administering the Workers' Compensation Act, The Pennsylvania Occupational Disease Act and the Office of Small Business Advocate for the fiscal year July 1, 2007, to June 30, 2008, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2007.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

- Section 1. The sum of \$63,383,000, or as much thereof as may be necessary, is hereby appropriated from the Workmen's Compensation Administration Fund to the Department of Labor and Industry for the payment of all salaries, wages and other compensation and travel expenses, for contractual services and other expenses necessary for the administration of the act of June 2, 1915 (P.L.736, No.338), known as the Workers' Compensation Act, and the act of June 21, 1939 (P.L.566, No.284), known as The Pennsylvania Occupational Disease Act, for the fiscal year beginning July 1, 2007, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2007.
- Section 2. The sum of \$174,000 is hereby appropriated from the restricted revenue account within the Workmen's Compensation Administration Fund to the Office of Small Business Advocate in the Department of Community and Economic Development as provided in the act of June 2, 1915 (P.L.736, No.338), known as the Workers' Compensation Act, for the operation of that office for the fiscal year July 1, 2007, to June 30, 2008.

Section 3. This act shall take effect July 1, 2007, or immediately, whichever is later.

AN ACT

SB 795

Making an appropriation from a restricted revenue account within the General Fund and from Federal augmentation funds to the Pennsylvania Public Utility Commission.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The following sums, or as much thereof as may be necessary, are specifically appropriated from the restricted revenue account within the General Fund and from Federal augmentation funds to the Pennsylvania Public Utility Commission to provide for the operation of the commission for the fiscal year July 1, 2007, to June 30, 2008, for the purposes and in the amounts shown:

Federal

State

For the salaries, wages and all necessary expenses for the proper operation and administration of the Pennsylvania Public Utility Commission, including the chairman and commissioners and the Bureau of Safety and Enforcement.

State appropriation

51,483,000

The following Federal augmentation amounts, or as much thereof as may be necessary, are specifically appropriated to supplement the sum authorized to be billed to utilities for the operation of the commission:

(1) "Natural Gas Pipeline Safety" - To enforce the regulations of the Natural Gas Pipeline Safety Act.

Federal appropriation

1,347,000

(2) "Motor Carrier Safety."

Federal appropriation

1,580,000

Any Federal funds which the Pennsylvania Public Utility Commission receives pursuant to these appropriations shall not be reimbursed to any utility.

Section 2. This act shall take effect July 1, 2007, or immediately, whichever is later.

AN ACT

SB 797

Making an appropriation from a restricted revenue account within the General Fund to the Office of Small Business Advocate in the Department of Community and Economic Development.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$993,000 is hereby appropriated from the restricted revenue account within the General Fund to the Office of Small Business Advocate in the Department of Community and Economic Development to provide for the operation of that office for the fiscal year July 1, 2007, to June 30, 2008.

Section 2. This act shall take effect July 1, 2007, or immediately, whichever is later.

AN ACT

SB 796

Making an appropriation from a restricted revenue account within the General Fund to the Office of Consumer Advocate in the Office of Attorney General.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$5,069,000 is hereby appropriated from the restricted revenue account within the General Fund to the Office of Consumer Advocate in the Office of Attorney General to provide for the operation of that office for the fiscal year July 1, 2007, to June 30, 2008.

Section 2. This act shall take effect July 1, 2007, or immediately, whichever is later.
