AN ACT

SB 812

Making appropriations from the Professional Licensure Augmentation Account and from restricted revenue accounts within the General Fund to the Department of State for use by the Bureau of Professional and Occupational Affairs in support of the professional licensure boards assigned thereto.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$43,946,000, or as much thereof as may be necessary, is hereby appropriated from the Professional Licensure Augmentation Account within the General Fund to the Department of State for the operation of the Bureau of Professional and Occupational Affairs, including the State Board of Auctioneer Examiners, for the fiscal year July 1, 2015, to June 30, 2016.

Section 2. (a) The sum of \$8,184,000, or as much thereof as may be necessary, is hereby appropriated from the restricted receipts account of the State Board of Medicine for the operation of the board for the fiscal year July 1, 2015, to June 30, 2016.

(b) The sum of \$1,523,000, or as much thereof as may be necessary, is hereby appropriated from the restricted receipts account of the State Board of Osteopathic Medicine for the operation of the board for the fiscal year July 1, 2015, to June 30, 2016.

(c) The sum of \$245,000, or as much thereof as may be necessary, is hereby appropriated from the restricted receipts account of the State Board of Podiatry for the operation of the board for the fiscal year July 1, 2015, to June 30, 2016.

(d) The sum of \$560,000, or as much thereof as may be necessary, is hereby appropriated from the Athletic Commission Augmentation Account for the State Athletic Commission, as authorized by 5 Pa.C.S. § 1512 (relating to Athletic Commission Augmentation Account), for the support and operation of the commission for the fiscal year July 1, 2015, to June 30, 2016.

(e) Each appropriation listed in subsections (a), (b), (c) and (d) shall not be treated as an augmentation to the Department of State, general government appropriation or any other appropriation, but shall be treated and accounted for as separate appropriations respectively.

Section 3. This act shall take effect July 1, 2015, or immediately, whichever is later.

SB 814

Making an appropriation from a restricted revenue account within the General Fund to the Office of Small Business Advocate in the Department of Community and Economic Development.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$1,306,000 is hereby appropriated from the restricted revenue account within the General Fund to the Office of Small Business Advocate in the Department of Community and Economic Development to provide for the operation of that office for the fiscal year July 1, 2015, to June 30, 2016.

Section 2. This act shall take effect July 1, 2015, or immediately, whichever is later.

Making an appropriation from a restricted revenue account within the General Fund to the Office of Consumer Advocate in the Office of Attorney General.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$5,268,000 is hereby appropriated from the restricted revenue account within the General Fund to the Office of Consumer Advocate in the Office of Attorney General to provide for the operation of that office for the fiscal year July 1, 2015, to June 30, 2016.

Section 2. This act shall take effect July 1, 2015, or immediately, whichever is later.

SB 816

Making an appropriation from the Public School Employees' Retirement Fund to provide for expenses of the Public School Employees' Retirement Board for the fiscal year July 1, 2015, to June 30, 2016, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2015.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$44,011,000, or as much thereof as may be necessary, is hereby appropriated from the Public School Employees' Retirement Fund to the Public School Employees' Retirement Board for the payment of all salaries, wages and other compensation and travel expenses of the employees and members of the Public School Employees' Retirement Board, for contractual services and other expenses necessary for the proper conduct of the duties, functions and activities of the board for the fiscal year beginning July 1, 2015, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2015.

Section 2. This act shall take effect July 1, 2015, or immediately, whichever is later.

SB 817

Making an appropriation from the State Employees' Retirement Fund to provide for expenses of the State Employees' Retirement Board for the fiscal year July 1, 2015, to June 30, 2016, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2015.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$23,743,000, or as much thereof as may be necessary, is hereby appropriated from the State Employees' Retirement Fund to the State Employees' Retirement Board for the payment of all salaries, wages and other compensation and travel expenses of the employees and members of the State Employees' Retirement Board, for contractual services and other expenses necessary for the proper conduct of the duties, functions and activities of the board for the fiscal year beginning July 1, 2015, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2015.

Section 2. This act shall take effect July 1, 2015, or immediately, whichever is later.

SB 818

Making appropriations from the Philadelphia Taxicab and Limousine Regulatory Fund and the Philadelphia Taxicab Medallion Fund to the Philadelphia Parking Authority for fiscal year July 1, 2015, to June 30, 2016.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$8,442,000 is hereby appropriated from the Philadelphia Taxicab and Limousine Regulatory Fund to the Philadelphia Parking Authority for the fiscal year July 1, 2015, to June 30, 2016.

Section 2. The sum of \$2,000,000 is hereby appropriated from the Philadelphia Taxicab Medallion Fund to the Philadelphia Parking Authority for the fiscal year July 1, 2015, to June 30, 2016.

Section 3. This act shall take effect July 1, 2015, or immediately, whichever is later.

AN ACT

SB 819

Making appropriations from a restricted revenue account within the General Fund and from Federal augmentation funds to the Pennsylvania Public Utility Commission for the fiscal year July 1, 2015, to June 30, 2016.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The following sums, or as much thereof as may be necessary, are specifically appropriated from the restricted revenue account within the General Fund and from Federal augmentation funds to the Pennsylvania Public Utility Commission to provide for the operation of the commission for the fiscal year July 1, 2015, to June 30, 2016, for the purposes and in the amounts shown:

For the salaries, wages and all necessary expenses for the proper operation and administration of the Pennsylvania Public Utility Commission, including the chairman and commissioners and the Bureau of Safety and Enforcement.		
State appropriation		69,640,000

The following Federal augmentation amounts, or as much thereof as may be necessary, are specifically appropriated to supplement the sum authorized to be billed to utilities for the operation of the commission:

- (1) "Natural Gas Pipeline Safety" - To enforce the regulations of the Natural Gas Pipeline Safety Act.
Federal appropriation 2,095,000
- (2) "Motor Carrier Safety."
Federal appropriation 966,000

Any Federal funds which the Pennsylvania Public Utility Commission receives pursuant to these appropriations shall not be reimbursed to any utility.

Section 2. This act shall take effect July 1, 2015, or immediately, whichever is later.

SB 820

Making appropriations from the restricted revenue accounts within the State Gaming Fund and from the State Gaming Fund to the Pennsylvania Gaming Control Board, the Department of Revenue, the Pennsylvania State Police and the Attorney General for the fiscal year beginning July 1, 2015, to June 30, 2016, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2015.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

PART I
PRELIMINARY PROVISIONS

Section 101. Short title.—This act shall be known and may be cited as the Gaming Control Appropriation Act of 2015.

PART III
STATE GAMING CONTROL
RESTRICTED REVENUE ACCOUNTS

Section 301. State Gaming Fund.—The following amounts set forth in this part, or as much thereof as may be necessary, are hereby appropriated from the State Gaming Fund restricted revenue accounts under 4 Pa.C.S. § 1401 (relating to slot machine licensee deposits) to the agencies of the Executive Department named in this part for the purposes set forth for the fiscal year beginning July 1, 2015, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2015.

Section 302. Attorney General.—The following amounts are appropriated to the Attorney General:

For salaries, wages and all necessary expenses of the Attorney General related to 4 Pa.C.S. Pt. II (relating to gaming).

State appropriation 1,192,000

Section 303. Department of Revenue.—The following amounts are appropriated to the Department of Revenue:

For the salaries, wages and all necessary expenses of the Department of Revenue related to 4 Pa.C.S. Pt. II (relating to gaming).

State appropriation 9,513,000

Section 304. Pennsylvania State Police.—The following amounts are appropriated to the Pennsylvania State Police:

For the salaries, wages and all necessary expenses of the

Pennsylvania State Police related to 4 Pa.C.S. Pt. II (relating to gaming).

State appropriation 27,700,000

Section 305. Pennsylvania Gaming Control Board.—The following amounts are appropriated to the Pennsylvania Gaming Control Board:

For the salaries, wages and all necessary expenses for the proper operation and administration of the Pennsylvania Gaming Control Board. This appropriation includes \$7,000,000 from the restricted revenue account established in the State Gaming Fund for fees and other revenues collected by the board.

State appropriation 39,900,000

PART V MISCELLANEOUS PROVISIONS

Section 501. Transfers prohibited.—There is no authority for the State Treasurer, the Secretary of the Budget, the Secretary of Revenue or the Pennsylvania Gaming Control Board to transfer any money within or between the appropriations in Part III.

Section 502. Effective date.—This act shall take effect July 1, 2015, or immediately, whichever is later.

SB 813

Making appropriations from the Workmen's Compensation Administration Fund to the Department of Labor and Industry and the Department of Community and Economic Development to provide for the expenses of administering the Workers' Compensation Act, The Pennsylvania Occupational Disease Act and the Office of Small Business Advocate for the fiscal year July 1, 2015, to June 30, 2016, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2015; and making an interfund transfer.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$71,966,000, or as much thereof as may be necessary, is hereby appropriated from the Workmen's Compensation Administration Fund to the Department of Labor and Industry for the payment of all salaries, wages and other compensation and travel expenses, for contractual services and other expenses necessary for the administration of the act of June 2, 1915 (P.L.736, No.338), known as the Workers' Compensation Act, and the act of June 21, 1939 (P.L.566, No.284), known as The Pennsylvania Occupational Disease Act, for the fiscal year beginning July 1, 2015, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2015.

Section 2. The sum of \$194,000 is hereby appropriated from the restricted revenue account within the Workmen's Compensation Administration Fund to the Office of Small Business Advocate in the Department of Community and Economic Development as provided in the act of June 2, 1915 (P.L.736, No.338), known as the Workers' Compensation Act, for the operation of that office for the fiscal year July 1, 2015, to June 30, 2016.

Section 3. For the purposes of further maintaining the Uninsured Employers Guaranty Fund, the sum of \$3,000,000 is hereby transferred to the fund from the Workmen's Compensation Administration Fund under section 446 of the Workers' Compensation Act.

Section 4. This act shall take effect July 1, 2015, or immediately, whichever is later.
