## LAW AGAINST TAKING AWAY BOATS OR CANOES.

Chap: 90 Be it &c: That if any person or persons whatsoever within this province or territories thereof, shall at any time after the publication herof take or Cary away any Boat, Vessell or Canow from any persons Landing, without Leave, hee shall be Lyable to pay for such his offence twice the Value of the boat, vessell canow; and the boat vessell or Canow, shall Remain still intire to the Master or Owner, and one half of the fine shall go to the Master or Owner.

Confirmed by chapter 154, 1684; chapter 175, 1685; chapter 186, 1688; and chapter 191, 1690. Abrogated in 1693, but accepted in Petition of Right, June 1, 1693, as chapter 48.

## LAW ABOUT FENCES.

Chap: 91 Be it &c: That all Corn-fields shall be fenced, and all fences shall be at Least 5 foot high, and for default thereof, such person shall be fined att the discretion of the County-Court.

Confirmed by chapter 154, 1684; chapter 175, 1685; chapter 186, 1688; and chapter 191, 1690. Abrogated in 1693, but accepted in Petition of Right, June 1, 1693, as part of chapter 49.

## LAW ABOUT CUTTING TIMBER.

Chap: 92 Be it &c: That if any Person within this Province or territories therof, shall at anie time after the publication hereof, presume to Cutt & fell any timber tree, upon the Land of anie other person, without Leave, Such person shall forfeit to the Owner thereof five pounds for every Such tree as aforesaid.

Confirmed by chapter 154, 1684; chapter 175, 1685; chapter 186, 1688; and chapter 191, 1690. Abrogated in 1693. Replaced by chapter 110, 1693.

CHAPTER 93.

LAW ABOUT FIREING WOODS.

Chap: 93 Be it &c: That whosoever Shall presume to Sett on fire any woods, Lands, or Marishes, in this Province or territories therof, befor the first day of the first month yearly They shall yearly make good all the damages that shall therby happen to any of the inhabitants therof.

Confirmed by chapter 154, 1684; chapter 175, 1685; chapter 186, 1688; and chapter 191, 1690. Abrogated in 1693, but accepted in Petition of Right, June 1, 1693, as chapter 50.

LAW ABOUT WEIRS.

Chap: 94 And be it &c: That there shall be No Weares made from One Side of any Creek or River to the other, And whosoever shall be Convicted of offending herein, shall for every Such Offence pay tenn Shillings, and the ware be destroyed.

Confirmed by chapter 154, 1684; chapter 175, 1685; chapter 186, 1688; and chapter 191, 1690. Abrogated in 1693. Replaced by chapter 103, 1693.

LAW ABOUT FERRIES.

Chap: 95 And be it &c: That there shall be ferry-boats for men & horses, built within one year, ensuing the first Session of this General-Assembly over the Creeks, Commonly Called, Neshaminee, Scuil-kill, & Christeen at the charges of the Countys they belong unto to be equally Leavied upon the inhabitants thereof, according to the propor-
