And so proportionably for greater or smaller sums in the same specie as the bills were drawn.

## CHAPTER 62.

[62] THE LAW AGAINST TRUSTING MARINERS.

To the end that no Mariners shall be arrested to hinder their Voyage, Be It Enacted by the Authority aforesaid, that no person, Ordinary Keeper or other within this province or territories thereof, shall trust any Mariner without the master of the Ship or Vessel (to whom such Mariners belong) engage for the same Otherwise to Lose what they So trust.

## CHAPTER 63.

[63] THE LAW ABOUT PASSES.

Be it Enacted by the authority aforesaid, That Unknown persons shall not presume, to travell, or go without the Limits of the County wherein they reside, without a pass or Certificate under the Seal of that County; And that in every County where such persons shall come, they shall renew their pass — And that every person offending herein shall be Liable to be apprehended & Sent back to the place from whence hee or shee came, at his or her proper costs and charges, to be Levyed on the goods and Chattells of Such Offenders by way of distress & Sale, if hee or shee be able, Or otherwise to be answered by the Master or Mistris of such Offenders — Always provided and It is hereby Enacted and declared that every person that Comes out of any other province, without the pass of that province such person belongs to, shall be apprehended and Secured in the house of Correction, where hee or shee shall Labour for his or her Sustenance, till Notice can be given to the Master or Mistriss of the said Servants; And till Such House of Correction be erected, the Sheriff of each County shall take Care to Secure the said Servant, And what charges Such Servant shall occasion more than his or her Work will defray, Shall be made good by the Master or Mistris of Such Servants, And such Master or Mistris shall over & above give to such persons as shall take them up twenty Shillings for their Reward

## CHAPTER 64.

[64] THE LAW AGAINST SELLING OF SERVANTS OUT OF THE PROVINCE.

It is further Enacted by the Authority aforesaid, That no Master or Mistris or freeman of this Province or Territories thereunto belonging Shall presume to Sell or Dispose of any servant or servants into any other province, that is or are bound to serve his or their time in the Province of Pennsilvania or territories thereof, Under the Penalty that every person so offending, shall for every Such Servant so Sold, forfeit ten pounds, to be Levyed by way of distress & Sale of their goods.

## CHAPTER 65.

[65] THE LAW AGAINST ATTACHING SERVANTS.

Be it Enacted by the Authority aforesaid, That no servant White or Black within this Province & Territories thereunto belonging, shall at any time after publication hereof be Attached or taken in execution for his Masters or Mistrisses debt or debts, To the end that the means of Livelyhood may not be taken away from the said Master or Mistris.
