

Three for the county of Bedford,  
 Two for the county of Northumberland,  
 Three for the county of Westmoreland,  
 Four for the county of Washington,  
 Two for the county of Fayette,  
 Two for the county of Franklin,  
 Four for the county of Montgomery,  
 Three for the county of Dauphin,  
 And one for the county of Luzerne.

Which persons so chosen from time to time shall be the general assembly of representatives of the freemen of Pennsylvania and shall have all and every the powers thereof for and during each of the said seven years respectively, according to the directions and the true intent and meaning of the said constitution and of the laws which are or shall be made in pursuance thereof.

## CHAPTER MCOLIV.

---

AN ACT TO REPEAL SO MUCH OF THE ACT, ENTITLED "AN ACT TO ENCOURAGE AND PROTECT THE MANUFACTURES OF THIS STATE BY LAYING ADDITIONAL DUTIES ON THE IMPORTATION OF CERTAIN MANUFACTURES WHICH INTERFERE WITH THEM,"<sup>1</sup> AS LAYS AN ADDITIONAL DUTY ON WINES AND FRUIT THE GROWTH OR PRODUCT OF THE KINGDOM OF PORTUGAL.

(Section I. P. L.) Whereas the additional duties of one shilling for every gallon of wine, five shillings for very box of lemons and seven shillings and six pence upon every hundred weight of raisins or other fruit, the said wine or fruit being of the growth of the kingdom of Portugal, or of the territories thereunto belonging, imposed by an act of the general assembly of this state, entitled "An act to encourage and protect the manufactures of this state by laying additional duties on the importation of certain manufactures which interfere with them," have been found burdensome to the commerce of this state without producing the goods effects intended thereby.

[Section I.] (Section II. P. L.) Be it therefore enacted and it is hereby enacted by the Representatives of the Freemen of the Commonwealth of Pennsylvania in General Assembly met and the authority of the same, That so much of the said recited act as lays an additional duty of one shilling on every gallon of wine and five shillings on every box of lemons and seven shillings and six pence for every hundred weight of raisins of the growth and produce of the kingdom of Portugal shall be, and the same is hereby repealed and made null and void.

## CHAPTER MCCLV.

---

AN ACT TO PREVENT FOR A LIMITED TIME THE SALES OF LANDS FOR THE PAYMENT OF TAXES WITHIN THE FRONTIER COUNTIES OF THIS STATE BELONGING TO NON-RESIDENT OWNERS THEREOF AND TO ALLOW THE SAID OWNERS A FURTHER DAY OF APPEAL.

(Section I. P. L.) Whereas the act passed on the eleventh day of September last for the relief of the owners of unimproved lands from the inconveniences they were subjected to by the mode established by law of enforcing the payment of taxes, respected such taxes only as should be assessed after the passing of that act:

And whereas sundry taxes before that time assessed remain uncollected and an immediate enforcing the payment thereof in the manner directed by the former laws will subject the owners of unimproved lands to all the inconveniences above referred to:

For remedy whereof:

[Section I.] (Section II. P. L.) Be it enacted and it is hereby enacted by the Representatives of the Freemen of the Commonwealth of Pennsylvania in General Assembly met and by the authority of the same, That the owners of unimproved and unoccupied lands lying within the counties of Northampton, Bedford, Northumberland, Westmoreland, Washington, Fayette and Luzerne or any of them on which any taxes have been assessed before the eleventh day of September last shall have
