

## CHAPTER MDVII.

## AN ACT TO MAKE PROVISION FOR REPAIRS AT MUD ISLAND.

(Section I, P. L.) Whereas the banks of Mud Island in the river Delaware have been and still are in a very dangerous and imperfect state notwithstanding that four hundred and ninety-six pounds eight shillings and three pence hath been expended thereon by direction of council very considerable repairs are still wanting to preserve the fort and other buildings from destruction:

And whereas no appropriation hath as yet been made by the legislature either for the sum already expended or for what may be farther necessary to complete said repairs:

And whereas the interest of the state requires that such provision should be made:

Therefore:

[Section I.] (Section II, P. L.) Be it enacted and it is hereby enacted by the Representatives of the Freemen of the Commonwealth of Pennsylvania in General Assembly met and by the authority of the same, That the sum of one thousand pounds moneys arising from the interest of the fifty thousand pounds loan be specially appropriated for the purpose of replacing the four hundred and ninety-six pounds eight shillings and three pence already expended on the banks of Mud Island by order of council as well as to provide a fund to complete the further repairs required on the banks of said island.

[Section II.] (Section III, P. L.) And be it enacted by the authority aforesaid, That the president and supreme executive council be and they are hereby authorized to employ suitable persons by contract to put the banks of Mud Island into good and desirable repair and to pay for the same by a warrant or warrants drawn upon the state treasury for any sum or sums to be paid out of the fund hereinbefore provided which together with the four hundred and ninety-six pounds eight shillings

and three pence already drawn for shall not exceed one thousand pounds.

CHAPTER MDVIII.

---

AN ACT FOR APPOINTING TWO ADDITIONAL TRUSTEES FOR THE COUNTY OF HUNTINGDON.

(Section I, P. L.) Whereas by the act for erecting part of Bedford county into a separate county by the name of Huntingdon county three of the five trustees therein named were appointed as residents in the town of Huntingdon for the greater convenience of forming a necessary quorum in order to the execution of the trust committed to them:

And whereas by the death of one of the said trustees, the removal of another from said town and the intention of a third to remove soon from the county there remains but one of the said trustees who has his usual residence in the said town and it is become difficult to assemble any three of the said trustees for the necessary business of the [county]:

For remedy whereof:

[Section I.] (Section II, P. L.) Be it enacted and it is hereby enacted by the Representatives of the Freemen of the Commonwealth of Pennsylvania in General Assembly met and by the authority of the same, That Andrew Henderson and Richard Smith of the town of Huntingdon aforesaid be and they are hereby appointed trustees in conjunction with the surviving trustees named in the said act and now residing within the said county, and they or a majority of them, heretofore and now appointed and residing within the said county shall have and execute all the powers, trusts and duties committed to the five trustees in the act for erecting the said county in the same manner and as fully as if the said Andrew Henderson and Richard Smith had been originally appointed trustees in the said act.
