

[Section I.] (Section I. P. L.) Be it therefore enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the said commissioners may and shall, on or before the first day of June next, open a book or books for the purpose of receiving subscriptions to the stock of the said company, and shall thereupon proceed in the like manner, shall give the same notice in the newspapers, and be subject to the same regulations and conditions, as are directed in and by the act to which this is a supplement.

(Section II, P. L.) And whereas by the fourth section of the said act the commissioners appointed to view and lay down the courses of the canals therein mentioned were directed to return a plan thereof, with topographical observations thereon, to the present general assembly, and it is apprehended that they may not be able to complete the same in the time limited. Wherefore:

[Section II.] Be it further enacted by the authority aforesaid, That the said commissioners may and shall be allowed to return the said plan, and perform the duties enjoined on them by the said act, at any time during the sitting of the present or before the end of the next succeeding, general assembly.

CHAPTER MDCCXXI.

AN ACT TO ERECT THE TOWNSHIPS OF COLEBROOKDALE, EARL DISTRICT AND HEREFORD, IN THE COUNTY OF BERKS, INTO A SEPARATE ELECTION DISTRICT.

[Section I.] (Section I. P. L.) Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the townships of Colebrookdale, Earl District and Hereford, in the county of Berks, are hereby

erected into a separate election district, to be called the seventh election district; and the freemen of the said district are hereby authorized to hold their annual elections at the house now occupied by Joseph Muthard, in Colebrookdale township aforesaid, any law in anywise to the contrary notwithstanding.

CHAPTER MDCCXXII.

AN ACT TO AUTHORIZE EDWARD SHYMER TO ERECT A DAM ON THE NORTH SIDE OF THE RIVER LEHIGH, IN THE COUNTY OF NORTHAMPTON.

Whereas it appears by the petition of a number of the inhabitants of the county of Northampton, that the erecting of a small dam, extending from the shore about five poles to a small island in the river Lehigh, would be of general utility to the inhabitants residing in the neighborhood thereof, without the least injury or obstruction to the navigation or fisheries in the same.

[Section I.] (Section I. P. L.) Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That Edward Shymer, of the township of Bethlehem, in the county of Northampton, his heirs and assigns, shall have liberty to erect a dam, to extend from the north shore of the river Lehigh about five poles to a small island in the said river, and to maintain the said dam in good repair forever, for the purpose of enabling the said Edward Shymer, his heirs or assigns, to erect a grist mill.

Provided always, That the said Edward Shymer, his heirs or assigns, shall erect, or cause to be erected and kept in good repair, a complete lock, twelve feet wide, on his head race, and empty into the dead water below the mill, through which boats and canoes may at all times safely and conveniently pass.

And provided also, That the said Edward Shymer shall not interfere with any private property on the said river.
