patent, under the great seal of this commonwealth, dated the thirteenth day of December, one thousand seven hundred and ninety, granting the same to the said mayor, aldermen and citizens, for the uses and trusts therein mentioned, and to apply the money arising from such sale to the purchase of such other lot or lots of ground, out of the bounds of the city, or the inhabited parts thereof, as they may judge suitable and necessary for a place of general interment of persons who may hereafter die in the city of Philadelphia, or the suburbs thereof.

CHAPTER MDCCLX.

A FURTHER SUPPLEMENT TO THE ACT, ENTITLED "AN ACT FOR THE SUPPORT OF THE GOVERNMENT OF THIS COMMONWEALTH." 1

Whereas it is not only proper, but just, that persons dedicating their time solely to the public service should have a reasonable compensation for the same.

[Section I.] (Section I, P. L.) Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the sum of five hundred dollars be allowed, per annum, to the clerk of the senate and house of representatives, respectively; and the sum of three hundred and fifty dollars be allowed, per annum to the assistant clerk of the senate and house of representatives, respectively,

to commence from the time of their respective appointments; and also the sum of four dollars per diem during the session of that branch of the legislature, for which they respectively officiate.

[Section II.] (Section II, P. L.) And be it further enacted by the authority aforesaid, That the following compensation shall be allowed to the officers hereinafter mentioned, viz., to the sergeant at arms and doorkeeper of the senate and house of representatives, respectively two dollars per diem, during the session, and one hundred and fifty dollars per annum, for extra services, to commence from the time of their appointment.

[Section III.] (Section III, P. L.) And be it further enacted by the authority aforesaid, That so much of any former act or acts of assembly, as makes an allowance to the clerk and assistant clerk of the senate and house of representatives, respectively, and to the sergeant at arms and doorkeeper of the said two houses, respectively, be, and the same is hereby, repealed and made null and yoid.

CHAPTER MDCCLXI.

AN ACT FOR THE RELIEF OF JOHN LAIRD.

Whereas it appears to the legislature of this commonwealth, that John Laird, in the month of August, in the year one thousand seven hundred and seventy-eight, in pursuance of orders given by John Travers, then sub-lieutenant of the county of York, expended the sum of two hundred and eighty pounds, to hire seven able bodied men to march to the Standing Stone, for the defence of the western frontiers of this state, which orders were given to complete the number of men required by an order of the then supreme executive council of this state, dated the fourteenth of July, in the year aforesaid. And whereas it appears that the aforesaid sub-lieutenant soon after became insolvent and insane, and that the said John Laird hath never been reimbursed the aforesaid sum of money. Therefore:
