eign port, in the port of Philadelphia, at the time of delivering his certificate or bill of health at the health office, one dollar, in full compensation for all services required of and enjoined on him by the said act, or this act.

(Section VI, P. L.) And whereas the funds heretofore provided for defraying the expense of the necessary improvements and repairs wanted at the health office, on State island, have not been productive and cannot be relied on for this purpose.

[Section VI.] Therefore, be it further enacted by the authority aforesaid, That the sum of five thousand dollars be appropriated to this purpose, out of the funds appropriated for the support of government, to be paid by the treasurer, on the warrant of the governor, to the inspectors of the health office, who shall duly account for the same in the manner of other public accountants.

[Section VII.] (Section VII, P. L.) And be it further enacted by the authority aforesaid, That there be allowed two dollars per day to every pilot detained on board any vessel compelled to perform quarantine at the health office, for every day he may be so detained, to be paid by the master or owner of such vessel respectively.

CHAPTER MDCCXC.

AN ACT FOR THE RELIEF OF CERTAIN PERSONS HAVING DEMANDS AGAINST THE COMMONWEALTH, FOR MATERIALS FURNISHED, AND WORK DONE, AT OR FOR THE HOUSE INTENDED FOR THE ACCOMBDATION OF THE PRESIDENT OF THE UNITED STATES.

Whereas sundry persons, who have at different times, before the twenty-second day of April last, furnished materials for, and performed work at or for, the house intended for the accommodation of the president of the United States, remain unpaid. owing to no fund having been provided by law for their just recompense: Therefore:

[Section I.] (Section I, P. L.) Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That it shall and may be lawful for the comptroller and register general to settle and adjust the accouns of such persons as have demands against the state for materials furnished, or work done, before the twenty-second day of April last, at or for the house intended for the accomodation of the president of the United States, and thereupon certify to the governor the balances due to such persons respectively, in the same manner as the said officers are by law authorized to do in other cases; and upon such certificates being sent to the governor, it shall and may be lawful for him to draw a warrant or warrants upon the state treasurer for the amount thereof, under the same regulations and restrictions as are by law prescribed in other cases.

[Section II.] (Section II, P. L.) And be it further enacted by the authority aforesaid, That a sum not exceeding five thousand dollars, of the moneys appropriated by the eighth section of an act, entitled, "An act supplementary to an act, entitled, 'An act to provide for paying and redeeming certain public debts, and for defraying the expenses of government, and for other purposes therein mentioned," passed the twenty-second day of April, one thousand seven hundred and ninety-four, be applied to the payment and discharge of such warrants as may be drawn by virtue of the next preceding section of this act.
