negotiate and borrow, upon the credit of their capital stock and incorporation, and the tolls and profits of the same, such sum or sums of money from time to time, as they shall be able to procure, and shall deem expedient and necessary for carrying on and completing the said work.

CHAPTER MDCCXCIII.

AN ACT TO ERECT A NEW ELECTION DISTRICT IN DAUPHIN COUNTY.

[Section I.] (Section I, P. L.) Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the township of Midddle Paxton, in the county of Dauphin, be, and the same is hereby, erected into a separate election district, to be called the seventh election district in the county aforesaid; and the freemen thereof are hereby authorized to hold their annual election at the house now occupied by John Ayres, in the manner and under the regulations prescribed by the constitution and laws of this commonwealth.

CHAPTER MDCCXCIV.

AN ACT TO PROVIDE FOR THE PAYMENT OF CERTAIN INCIDENTAL EXPENSES OF THE LATE SENATE.

Whereas certain demands, arising from transacting the business of the late senate remain unpaid:

[Section I.] (Section I, P. L.) Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the governor of this commonwealth be, and he is hereby empowered to draw warrants on the state treasurer in favor of the persons following, for the several sums of money annexed to their respective names, viz: To Zachariah Poulson, Junior, printer of the journal of the late senate, one hundred and thirty dollars; to Michael Billmeyer, for printing the journal of the same in the German language, the sum of one hundred and eighty-two dollars; to Thomas Dobson, for stationery, forty dollars and fourteen cents; which warrants shall be paid by the treasurer, out of the funds appropriated to defray the expenses of government, and shall be available to him in the settlement of his accounts for the sum or sums therein expressed.

CHAPTER MDCCXCV.

AN ACT TO EXTEND AN ACT, ENTITLED, "AN ACT TO ENABLE ALIENS TO PURCHASE AND HOLD REAL ESTATES WITHIN THIS COMMON-WEALTH."¹

Whereas the act entitled, "An act to enable aliens to purchase and hold real estate within this commonwealth" will expire at the end of the next session of the general assembly, and it is expedient to continue the same for a longer period: Therefore:

[Section I.] (Section I, P. L.) Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the act, entitled, "An act to enable aliens to purchase and hold real estates within this commonwealth," shall continue in force for the term of two years from the passing of this act.
