any kind, within the said western moiety of the market house or shambles aforesaid.

[Section II.] (Section II, P. L.) And be it further enacted by the authority aforesaid, That the mayor, aldermen and citizens of Philadelphia shall have power to make and enforce such by-laws, rules and ordinances, as may be found expedient for the purpose of carrying this act into execution, conformably to the true intent and meaning thereof.

[Section III.] (Section III, P. L.) And be it further enacted by the authority aforesaid, that the mayor, aldermen and citizens of Philadelphia, in common council assembled, be, and they are hereby, authorized to assess, levy and collect from the inhabitants of the said city, and upon all estates real and personal, and taxables within the same, such sum or sums of money as they may deem necessary to enable them to extend the market in High street, whenever they may think proper so to do, which taxes shall be levied and collected in the same manner as the city taxes are.

[Section IV.] (Section IV, P. L.) And be it further enacted by the authority aforesaid, That when the market shall be so extended, the one half of the buildings erected shall be and remain free for the country people bringing the produce of their farms to market forever, and agreeably to what is directed by the first section of this act; and that no fees, tolls or perquisites be demanded or exacted from them for the use thereof.

CHAPTER MDCCXCVII.

AN ACT TO ERECT THE TOWNSHIPS OF LACKAWANNA, EXETER AND PROVIDENCE, IN THE COUNTY OF LUZERNE, INTO A SEPARATE ELECTION DISTRICT.

[Section I.] (Section I, P. L.) Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by

the authority of the same, That the townships of Lackawanna, Exeter and Providence, in the county of Luzerne, are hereby erected into a separate election district, to be called the Lackawanna district, in the county aforesaid; and the freemen of the said district shall hold their annual elections at the house of William Hooker Smith, in the township of Lackawanna aforesaid.

CHAPTER MDCCXCVIII.

AN ACT TO AUTHORIZE BENJAMIN ELLIOT TO ERECT A WING DAM ON THE EAST SIDE OF THE RIVER JUNIATA, IN HUNTINGDON COUNTY.

Section I.1 (Section I, P. L.) Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That Benjamin Elliot, his heirs and assigns, be, and they are hereby authorized and empowered to erect a wing dam on the river Juniata, in the county of Huntingdon, to extend not more than two-thirds across the said river. and to keep the same in good repair forever, and also to lead off thereby on his own land so much of the water of the said river as may be found necessary for the supply of his water works: Provided always, That the said Benjamin Elliot, his heirs or assigns, in erecting the said wing dam, or in keeping the same in repair, or in drawing off the water as aforesaid, shall not thereby in any degree injure or impede the navigation of the said river, to prevent fish from passing up the same: And provided also, That the said Benjamin Elliot shall not interfere with any private property on the said river.

[Section II.] (Section II, P. L.) And be it further enacted by the authority aforesaid, That on complaint of any person or persons to the judges of the court of quarter sessions of the said county, it shall and may be lawful for the said judges to
