

shall be and remain vested in, and be confirmed to, the members of the said first Presbyterian church and their successors forever, and that the right, title, interest and property of, in, and to the third Presbyterian church in Pine Street in the city of Philadelphia, the site thereof, and the burial ground thereto annexed, being the lot granted by the late proprietaries to the members of the first Presbyterian church, for the purpose of erecting a church thereon and other purposes therein mentioned, shall go to, vest in, and be confirmed to, the members worshipping in, and now in the possession of the third Presbyterian church and their successors forever, and be holden by them as their several, sole and separate estate, anything in the said charter of incorporation to the contrary thereof in anywise notwithstanding.

CHAPTER MDCCCLXXXV.

AN ACT TO PROVIDE FOR THE COMPLETION OF THE HOUSE INTENDED FOR THE ACCOMMODATION OF THE PRESIDENT OF THE UNITED STATES.

Whereas the sums hitherto appropriated for the purpose of erecting and finishing an house for the accommodation of the president of the United States have by reason of the great increase which has taken place in the price of materials and labor become insufficient to complete the same.

[Section I.] (Section I, P. L.) Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the governor be and he is hereby authorized and required to contract with some suitable person or persons for completing and finishing the building intended for the accommodation of the president of the United States and

to take security of any person or person so contracting for the faithful performance of such contract or contracts.

Provided always, That the whole expense to be incurred for the completing and finishing the same shall not exceed the sum of thirty thousand dollars.

[Section II.] (Section II, P. L.) And be it further enacted by the authority aforesaid, That the sum of thirty thousand dollars be and the same is hereby appropriated out of the aggregate funds of this commonwealth for the payment and discharge of all the warrants drawn by the governor in pursuance of this act which warrants the state treasurer is hereby authorized and directed to pay out of the funds last mentioned.

CHAPTER MDCCCXXXVI.

AN ACT TO ESTABLISH A PUBLIC FERRY OVER THE RIVER JUNIATA OPPOSITE THE TOWN OF HUNTINGDON IN THE COUNTY OF HUNTINGDON AND VESTING THE RIGHT IN THOMAS WHITAKER HIS HEIRS AND ASSIGNS.

[Section I.] (Section I, P. L.) Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That it shall and may be lawful from and after the passing of this act for Thomas Whitaker, his heirs and assigns at his or their own proper cost and charge to make or cause to be made good and convenient landings upon both sides of the river Juniata opposite the end of Montgomery's Street, in the town of Huntingdon, where he at present keeps a ferry, and shall at all times hereafter maintain the same in good order and repair fit for men, horses and carriages to pass and repass, and further the said Thomas Whitaker, his heirs and assigns shall provide and maintain a good and substantial boat or boats and careful ferrymen who shall duly and constantly as
